### Corporate Actions Committee – Athens Stock Exchange (ATHEX)

---

Following the announcement of the results of the Hellenic Republic's Exchange Offer on November 30<sup>th</sup>, 2017, the Athens Stock Exchange, during today's session of its Corporate Actions Committee:

- **approved** the listing of the following new Bonds of the Hellenic Republic, issue date 05.12.2017 and nominal value of €1.00 each:
  - **4,355,990,324** bonds, 5 years duration, fixed interest rate of 3.50%, ISIN GR0114030555
  - **5,962,747,327** bonds, 10 years duration, fixed interest rate of 3.75%, ISIN GR0124034688
  - **6,091,218,404** bonds, 15 years duration, fixed interest rate of 3.90%, ISIN GR0128015725
  - **4,805,399,486** bonds, 19 years duration, fixed interest rate of 4.00%, ISIN GR0133011248
  - **4,603,713,186** bonds, 24 years duration, fixed interest rate of 4.20%, ISIN GR0138015814
